A. State Controlled Maintenance 5-Year Plan (attachment: Five Year Controlled Maintenance Project Plan FY 19-20 to FY 23-24)

Traditionally a submittal for a State Controlled Maintenance request is prepared annually with input from the three institutions and is submitted to the Office of the State Architect (OSA) for their review and inclusion in their annual State report for submittal to the State Appropriation Committee for funding consideration. At the May 2018 Auraria Board meeting, the Capital Renewal Plan was presented and approved. This plan potentially gains \$18M in benefit for the campus, if approved through the State process. Consequently, as was discussed, in recognition of that significant request (which also goes to the OSA), the Campus will waive its collective FY 19-20 request for the annual controlled maintenance (commonly funded at approx. \$1M).

The Five Year Controlled Maintenance Project Plan has been developed with this commitment in mind, reflecting a zero dollar request for year one, and subsequent more traditional requests for years two through three. Years two through three will be refined over time and will continue to be presented to the Auraria Board on an annual basis.

Recommended Motion: That the Auraria Board of Directors approve the Five-Year Controlled Maintenance Project Plan: FY 19-20 to FY 23-24, with the acknowledgement that the Year One request is at zero dollars.
