

# **AURARIA CAMPUS POLICY**

Policy Title:	Banning or Exclusion of Persons from the Auraria Campus

### 1. Purpose:

The Auraria Board owns and manages the Auraria Campus for the use and benefit of its constituent institutions of higher education – the Community College of Denver (CCD), Metropolitan State University of Denver (MSU Denver), and the University of Colorado Denver (CU Denver) – and to facilitate and further their respective educational missions. Section 23-70-106, C.R.S., authorizes the Auraria Board to promulgate rules and regulations for the safety of students, employees, and property on the Auraria Campus. The purpose of this policy is to provide a standard for banning or excluding persons from the Auraria Campus who present a danger to the campus community, disrupt the orderly functioning of the campus, or whose presence is otherwise deemed detrimental to the campus community or incompatible with the function of the campus.

#### 2. Audience:

This policy applies to all employees, students, and visitors on the Auraria Campus.

## 3. Policy:

The Board of Directors of the Auraria Higher Education Center, acting through its Chief Executive Officer, reserves the right to exclude from the Auraria Campus those persons whose conduct is deemed (a) detrimental to the well-being of the employees, students, or visitors on the Auraria Campus, or (b) incompatible with its function as a center of higher education or the missions of its constituent institutions.

- The Chief Executive Officer will establish the necessary procedures to carry out the intent
  and purpose of this policy, including procedures for notifying persons that may be banned
  or excluded, and for hearing appeals and requests for reconsideration by such persons.
- The Chief Executive Officer may delegate his/her authority to ban or exclude persons from the Auraria Campus, as well the authority to consider appeals or requests for reconsideration of such decisions.
- In the event a constituent institution requests that the Auraria Higher Education Center ban or exclude one its employees, students, or visitors from the Auraria Campus, the institution shall provide with its request evidence sufficient to warrant banning or exclusion under the standards stated above under Policy.
